WHAT IS CONVEYANCING?

Conveyancing is the legal process of transferring the ownership of a property.

Whenever you buy or sell a property, you'll need a conveyancer to look after your legal interests, and ensure everything is properly done and goes as smoothly as possible.

A conveyancer will make you aware of any restrictions on the property you are buying, and will secure the ownership and rights of the property and land for you (the title).

Our conveyancing service

You can use Yorkshire Building Society's conveyancing service if you are buying a new home, selling a property or changing the legal owner of a property (referred to as a "transfer of equity"), by asking one of our team to help you find a quote.

Our online referral system can help find the best deal from over 120 firms of solicitors and licensed conveyancers.

The quotes you receive will include all known costs, allowing you to budget effectively for your conveyancing services alongside any other mortgage-related expenses.

How it works

Once you've chosen a conveyancer, you'll receive an introductory pack. Then, as soon as you've completed and returned the necessary documentation, your conveyancer will begin the process of applying for searches, raising enquiries and sending you a report, including the legal document you sign to formalise your mortgage agreement (your mortgage deed) and the binding agreement to purchase your property (your purchase contract).

They'll help you right the way through to exchange of contracts and completion day, and you'll be kept fully informed throughout the process – you can even track your conveyancer's progress online.
